
Item No.14: Any Other Business:

- (i) The PhD scholar, Mausam Paul applied for 6 months extension wef 09.09.2021 after completion of 5 years. The Board observes that the scholar is eligible for seeking reregistration wef 09.09.2021 and the COVID-19 related UGC notification dated 15 Dec'2020 is not applicable in this regard. The Board observed that in case the candidate is not able to submit before the expiry of 5 year tenure, then he may seek re-registration after expiry of 5 years as per rules.
- (ii) The PhD scholar, Himangshu Sharma will be completing 2 years of re-registration (total 7 years) on 08.09.2021. The scholar sought 8 months additional time after completion of 7 years wef 09.09.2021 due to valuable time lost during COVID-19 pandemic. As no laboratory based experiments could be conducted during the pandemic period from March-November'2020, the Board observes that the appeal may be considered favourably and recommend to the BRS for consideration of approval as a special case.

(iii) NAAC preparation

Regarding the NAAC preparation, the HoD, Dept. of Ecology & Env. Sc. informed that the faculties are involved in the preparation process as per IQAC's suggestions.
