The Georg-August-Universität Göttingen as Coordinator of **NAMASTE** awards the grant according to the rules and regulations set by the European Community Mobility Programme "**Erasmus Mundus Action 2, Strand 1**" (EMA2). The decision is conditional to a formal approval from the Education, Audiovisual and Culture Executive Agency (EACEA) and to the signing of an agreement between the EACEA and the Georg-August-Universität Göttingen.

The scholarship will only be granted under the condition that:

- You are accepted by the host university and are subject to the conclusion of a Scholarship Award Agreement specifying the terms and conditions of the grant.
- You were enrolled in your home university at the time of application (for TG1).
- You prove the approval of your home university by providing a Learning Agreement signed by the home university before departure (for Exchange Master and Bachelor students).
- You provide a research plan (for PhDs and Post-Docs) or a teaching/research/training plan in consultation with the host university (for Staff) and have it signed by the home university before departure.
- You did not obtain a scholarship of the same level under any Erasmus Mundus programme.
- You have not resided, nor carried out your main activity (studies, work, etc) for more than a total of 12 months over the past 5 years in one of the European Countries. This, however, does not apply for Staff grantees nor for Target Group 3 grantees.

Please note that your scholarship should start before **31st December 2015**. However, the Staff mobility (1 month) can start after 31st of December 2015, provided that it is completed before the end of the project (**14 July 2017**). As a NAMASTE grantee, you will be receiving a monthly subsistence allowance determined by your mobility level.

Please refer to the table below:

Level	Amount of subsistence allowances
Undergraduates and Masters	1.000 EUR / month
Doctorates	1.500 EUR / month
Post-Doctorates	1.800 EUR / month
Staff	2.500 EUR / month

As Coordinator of the **NAMASTE** Project the Georg-August-Universität Göttingen will be responsible for the travel costs as well as for the insurance costs (health, travel, liability, and accident insurance) of the grantees.

The regulations and procedures concerning payments of grants, travels, insurance and other formalities attached to the mobility grant are described in the Scholarship Award Agreement Template, which can be found on the Grant Holder Pages. All grantees should read the regulations and procedures prior the mobility period.

If you wish to reject the grant, please state the reason for withdrawal.
