**Office order**

**Shri Pintu Saha**, a Ph.D. scholar, is hereby appointed as a State Junior Research Fellow in the Department of Instrumental Music with a fellowship of Rs.16,000.00 per month (consolidated) on the basis of the recommendation of the Selection Committee held on 22.07.15 and subsequent approval of the Hon'ble Vice-Chancellor of the University, initially for a period of two years as JRF w.e.f. the date of joining.

The fellowship is tenable for a total period of four years (one year can be extended more in deserving cases) or submission of Ph.D. thesis whichever is earlier. The fellowship will be effective from the date on which he/she joins subject to the following conditions:

- 1) He/She shall devote his/her full time to the research work approved by the University and he/she must not accept any emoluments/honorarium/scholarship/ stipend from any other source during the tenure of this award. A declaration in this regard is to be submitted along with the claim of monthly Fellowship and the format of declaration is available with the Development department.
- 2) He/She shall participate in all academic programmes of the department including taking classes etc. as may be assigned to him/her by the Head of the Department.
- 3) He/She shall furnish annual progress report on her research work through his/her Supervisor to the University.
- 4) If a fellow wishes to leave the fellowship during his/her tenure of fellowship for any reason whatsoever or wishes to appear in any examination conducted by any University or public body it should be done with the prior permission of the University;
- 5) He/She shall be subject to such other terms and conditions as may be laid down by the competent authorities on this behalf from time to time;
- 6) This appointment order shall remain valid for one month from the date of issuance of this order. In the event of his/her failure to report for duty within a month, the appointment shall stand cancelled without further reference to him/ her.
- 7) He/She shall produce the mark sheets and certificates of the examinations passed, all in original, at the time of joining to the undersigned/ Development Department for records.
- 8) The offer of appointment of a State Junior Research Fellow remains valid for 30 days w.e.f 03.08.2015.
