10. Duration for completion: **15 days from the date of placing order.**


**Terms & conditions:**

2. The suppliers/ printers should quote rate with sample, which should be inclusive of all taxes, freight or any other charges etc. The rate so quoted should be F.O.R. Assam University, Silchar. The Firm should submit Sales Tax & Income Tax clearance Certificate & also submit PAN Card & TIN number.
3. The firm should have experience in similar printing work. The relevant certificate/document as proof may be submitted at the time of depositing tender documents.
4. The rate quotations submitted should be accompanied with a "Call deposit" of Rs. 5000/- (Rupees Five thousand) only from any Nationalized Bank pledged in favour of "Assam University, Silchar".
5. VAT/Income Tax or any other Taxes as admissible will be deducted at source. While accepting the rates, the quality of item vis-a-vis the rate shall be taken into consideration. The lowest rate shall not be the sole criteria for accepting the rate.
6. The rate quotations submitted should be in a sealed envelop superscribed as Rate for Printing of **Students Magazine "Prachi Prangan"** for the year 2016-17 and addressed to "The Registrar, Assam University, Silchar".
