Terms and conditions for the submission of Quotation

E-tender is invited on behalf of The Registrar, Assam University, Silchar, Assam from the reputed manufacturers/authorized distributors/dealers (who have the current authorization from the principal company) for entering into Annual Rate Contract for the supply of items mentioned above.

- 1. The quotation should be submitted to online eprocurement portal CPPP (<u>https://eprocure.gov.in/eprocure/app</u>) and Technical Bid documents should be submitted to sealed covers, super scribing **Tender for rate contract**, Tender No., due date, and addressed to The Registrar, Assam University, P.O –Dargakona,Silchar 788011, Assam. <u>Offers sent through Fax or E-mail will not be accepted.</u>The Registrar, Assam University is not responsible for any transitional/postal delays.
- The quoting firm should submit the bid submission format as per Annexure-II along with the quotation for technical qualification. In case the firm wishes to quote for more than one category of item, the firm should submit separate bid submission format (Annexure-II) for each category along with the respective supporting documents/price list.
- 3. The bid should be complete in all respects and should be **duly signed at every page**. Overwriting and corrections in the bid documents are not encouraged and, if any, should be attested properly. Incomplete and unsigned bids will not be considered.
- 4. In case, the certificate/information provided by the quoting firm is found false at any stage of the tender process or after the rate contract, the University will reject the bid or cancel the rate contract without any further intimation.
- 5. There will be no change in price structure during the currency of contract except of the statutory levies which are made applicable by the Govt. through notifications / regulations change.
- 6. The price should be inclusive of delivery chargesuptothe respective campuses of Assam University (Silchar/Diphu).
- 7. Prices charged for the items supplied under Rate Contract should under no event be higher than lowest prices at which the party sells the items of identical description to any other Govt. organization / Private Organizations during the period of contract. In case it is found that the price charged by the firm is more, the same will be recovered from the subsequent/unpaid bill of the supplier.
- 8. The ordered items shall be supplied within a period of 45 days either directly or through dealer. Earlier delivery by the supplier is preferred.
- 9. Assam University reserves the right to enter into parallel Rate Contract for similar items during the period of Rate Contract with one or more parties.
- 10. Termination of Rate Contract The rate contract can be terminated at any time without assigning any reasons by giving two months' notice by either party.
- 11. Conditional, Unsigned, Late & Delayed tenders will not be considered.



- 12. If the supplier fails to deliver the material within the delivery period as specified, purchaser may procure such items as deemed appropriate for.
- 13. The supplier will be liable to the purchaser for any excess costs incurred for procurement of goods or services not delivered in time.
- 14. The tenderer shall be fully responsible for the manufacturer warranty in respect of quality and workmanship of the materials covered in the Rate Contract. In case of any defects found at the time of use, the supplier will provide free replacement or refund the amount charged for that item(s).
- 15. The University reserves the right to test the chemicals and solvents/other consumables for their quality if it so desires. The items, so supplied will have to be of high quality and grade and in the inspection/test if these are found to be of inferior quality, the same are to be replaced by supplier at their cost within the stipulated period, failing which the RC of the firm may be cancelled. Delayed supply/non-compliance of complete order may also lead to cancellation of the RC.
- 16. Bidders are requested to provide complete Bank details (as per **Annexure IV**) with branch code, Account No., IFSC so that payment can be sent electronically.
- 17. No advance payment will be made for the supplies.
- 18. Discount, taxes and other levies if any are to be specified clearly in the bid.
- 19. The order for the rate contract shall be given to the qualified firms initially for the period of one year and the same may be extended to further period subject to the satisfactory performance of the qualified firm and the submission of prevailing price list at the time of extension of rate contract for the subsequent year/period. For the extension of rate contract, all terms and conditions should be as per the original tender document.
- 20. The University is exempted from paying Customs and Excise duty. The University is covered under the Ministry of Finance Notification No. 45/2017-Central Tax (Rate) Dated 14th November, 2017 and subsequent amendment Notification No 9/2018-Central Tax (Rate) Dated 25th January, 2018.
- 21. It is mandatory for all the bidding firms/manufacturers who are having online catalogue with dynamic pricing that, the price of an item obtained from their online portal on a date shall remain valid for a minimum period of one year.
- 22. The bidders are required to submit soft copies of their bids electronically on the e-bid Portal, using valid Digital Signature Certificates. REGISTRATION

1. Bidders are required to enrol on the e-Procurement Portal (<u>https://eprocure.gov.in/eprocure/app</u>) by clicking on the link "Online bidder Registration" on the e-bid Portal.

2. As part of the enrolment process, the bidders will be required to choose a unique user name and assign a password for their accounts.

3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication with the bidder.

4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Only Class III Certificates with signing + encryption key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.

5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.

6. Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token.

SEARCHING FOR BIDDING DOCUMENTS

9. There are various search options built in the e-bid Portal, to facilitate bidders to search active bids by several parameters. These parameters could include Bid ID, Item/work id, Last date of submission, etc.

PREPARATION OF BIDS

10. Bidder should take into account any addendum and corrigendum published on the bid document before submitting their bids.

11. Please go through the bid advertisement and the bid document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

12. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the bid document / schedule and generally, they can be in PDF /JPEG formats. Bid Original documents may be scanned with 100 dpi with Colored option which helps in reducing size of the scanned document.

SUBMISSION OF BIDS

13. Bidder should log into the website well in advance for the submission of the bid so that it gets uploaded well in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.

14. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the bidding document.

15. ***Bidders** are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the bid document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

16. The server time (which is displayed on the bidder's dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.

17. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener public keys. Overall, the uploaded bid documents become readable only after the bid opening by the authorized bid openers.

18. The uploaded bid documents become readable only after the bid opening by the authorized bid openers.

19. Upon the successful and timely submission of bid click "Complete "(i.e., after Clicking "Submit" in the portal), the portal will give a successful Bid submission acknowledgement & a bid summary will be displayed with the unique id and date & time of submission of the bid with all other relevant details.
