In order to avoid this overlapping and hardship faced by examination department/evaluation zone, the extant duration for submission of RTI application by student may be reduced to one month from the date of declaration of semester result.

Item No. 9 : UGC Public notice regarding Draft Curriculum and Credit Frame Work for Post Graduate Programme :

AC:96:04-24:9 : The UGC vide email dtd. November 20, 2023 has forwarded the UGC Public notice regarding Draft Curriculum and Credit Frame Work for Post Graduate Programme for perusal by the University and the views of the Chairman, NEP 2020, Assam University was obtain.

The detail of the points covered by the University was noted in respect to different Clauses under the Programme. The CoE was also consulted in respect to particular Clauses. The Chairman, NEP 2020 Implementation Committee for PG courses, Prof. Manabendra Dutta Choudhury shall place the matter before the Council. The UGC Public Notice was placed in the meeting.

The matter was placed before the Council for consideration and decision.

Resolution : As narrated by the Chairman, NEP Implementation Committee, the Council noted that the Credit Frame Work for PG curriculum of Assam University is at par with the structure proposed by UGC.

It is resolved that the new method of assessment, grading system and credit calculation method as proposed by UGC Credit Frame Work shall be implemented from the next academic session of the University as recommended by CoE.

The Council resolved that all PG Dept. should explore the possibilities of initiating 5 year integrated course as per UG Credit Frame Work. It is also resolved that admission to PG courses shall be based on CUET score irrespective of major or minor courses of the candidate at UG level.

School of Technology shall now implement the Clause 11.0 of UGC Credit Frame Work where it is mentioned that : "Candidates who have completed 4-year undergraduate programme or a 3 year UG and 2 year Master's programme or 5 year integrated programme (UG + PG) in Science, Technology, Engineering and Mathematics (STEM) subjects will be eligible for admission in M.E., M. Tech. in allied areas".

The Council recommended the same to Executive Council for approval.

Item No. 10 : Proposal for opening of a new Diploma course on "Climate change adaptation and Disaster Risk Mitigation" (CCA & DRM) under the Dept. of Ecology and Environmental Science :

AC:96:04-24:10 : The proposal was placed in the 95th AC meeting vide resolution No. AC:95:09-23:16 and it was resolved that the matter would be forwarded to the IQAC for views. However, on the queries of the Director, IQAC the Dean, School of Environmental Sciences has proposed now as follows :

- (i) It would be a "Diploma Course"
- (ii) Eligibility criteria for taking admission may be Science graduate
- (iii) The Seat capacity may initially be kept as 20

Item No. 12 : Online P G diploma in Data Science :

AC:96:04-24:12 : The Head, Dept. of statistics has submitted that a self financing course called “Online Post Graduate Diploma in Data Science” was started in the department from the last academic session after proper approval of the competent authority. This year only two candidates have applied for the same and as the course is self financing one, it might be difficult to run the expenses of the course with such poor enrolment of students.

In this situation, the department decided that :

- (i) Not to conduct the programme in the current academic session.
- (ii) If possible return the application fees of the few applicants of the online P G Diploma in Data Science programme.

In this regard, the views of Director, IQAC was sought and the Director, IQAC was of the opinion that :

- May be considered the decision of the department.
- Fee to be returned including application fee for all the candidates.
- Dept. should be advised to ensure the sustainability of courses, before implementing.

The matter was placed before the Council for decision.



Resolution : The Council discussed on the submission of Head, Dept. of Statistics and advised that the Department shall review the decision and shall rethink for exploring ways for starting the course again.

- (iv) Examination branch will issue paper setting and evaluation letters accordingly.
- (v) After result declaration of the arrear courses, marks and credits will be uploaded to ABC portal by the Examination branch.
- (vi) Since the ratio of marks in internal assessment and end semester examination of Assam University is not same as NPTEL marks (25:75 in NPTEL and 30:70 in Assam University) the scaling mechanism may be adopted for such students.


