FOR THE POST OF PRINCIPAL, RABINDRASADAN GIRLS' COLLEGE, KARIMGANJ, ASSAM

In pursuance to the permission accorded by the Director of Higher Education, Assam vide letter No. E. Comp. No 572315/2024 dated 30/10/2024 applications in prescribed format with complete biodata including contact number, valid E-mail ID and all supporting testimonials from HSLC (10th standard exam.) onwards are invited from intending candidates for filling up the post of Principal (for the period of 5 years) in Rabindrasadan Girls' College, Karimganj, Assam, Pin - 788710. The Application must be submitted through the proper channel with an NOC from the concerned authority. Necessary qualifications, experience, the latest norms etc. as prescribed by the latest UGC regulations and Govt. of Assam guidelines (Govt. OM No. AHE 45/2019/2, dated 25/02/2019):

1. A Master's degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) by a recognised University.
2. A Ph.D. degree in concerned/allied/relevant discipline(s) in the institutions concerned with evidence of published work.
3. Professor/ Associate Professor with a total service/experience of fifteen years of teaching/research in Universities, Colleges and other institutions of Higher Education.
4. A minimum score as stipulated in the Academic Performance Indicator (API) based on the Performance Based Appraisal System (PBAS) as set in the UGC regulations in appendix III for direct recruitment of Professors in Colleges.
5. A minimum of 10 research publications in peer-reviewed or UGC-listed journals (must attach self-attested valid supporting documents)
6. A minimum of 110 Research Score as per Appendix-II at Table-2 (UGC guidelines dated 18-07-2018).
7. A relaxation of 5% marks may be provided at the Graduate and Master's level for the Schedule Caste/Schedule Tribe/Differently abled (Physically and Visually Different abled) categories for the purpose of eligibility and for assessing good academic records. The eligibility marks of 55% or an equivalent grade in a point scale wherever grading system is followed and the relaxation of 5% to the categories mentioned above are permissible based on only the qualifying marks without including any grace mark procedures.
8. A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph. D degree holders, who have obtained their Master's degree prior to 19th September, 1991.
9. The upper age limit is 55 years as prescribed rules.
